Motion 1. - Appointment to Vicar of Outreach, St. Joan Project

Where she will be responsible for the daily operations of the "St. Joan Outreach" project This project is designed to provide vital communications after disasters with the application of donated computers and remote internet services. Item 4. - Report from Buildings and Grounds Committee

Four potential sites have been located and we are awaiting more financial data before committing any resources towards moving on these properties.

Site 1 – Established Church, has been placed on and off the market several times at about \$500,000. Is located in downtown Maysville and has a small sanctuary, some office space and an educational building,

Site 2 – Established Church, located in downtown Maysville and was rumored to be offered to the City of Maysville for \$400,000 before public outcry at the proposed use of "Flies Storage" caused the city council to negate their plans. Has a large sanctuary with some office space and nearly no parking or other grounds.

Site 3 – Residential and Commercial complex located near the downtown area of Maysville. Current land/building values of about \$130,000/acre in the area, this would need to be purchased and re-zoned and then cleared and rebuilt – estimated costs could negate this plan.

Site 4 – Established Church property – currently appears abandoned. Is located outside the city of Maysville about 3 miles – but is within the postal service and address of Maysville. We are currently unable to locate tax records or recorded plots for the land. It has significant over growth of brush on the property but does not appear to be suffering too greatly from that. It would take a significant investment to prepare this land and possibly need re-zoning.
